### Conservation Commission Meeting December 21, 2023

Chair Zacchilli called to order the meeting of the Milford Conservation Commission at 7:00P.M.

#### 7:01 P.M. - #30 Littlefield Rd – Certificate of Compliance DEP# 223-1204

Representative in attendance were Jen Bartolotta and Paul Disimone from Colonial Engineering.

Town Engineer completed a site inspection of the pool and found rocks excavated for the pool were disposed of at and in the wetland. With the installation of the fence around the pool, access to the boulders is limited. Applicant would like the Commission to consider allowing the rocks to remain or to allow disturbance to the wetlands to remove the boulders.

Motion by Roda second by Frederick to continue, to allow resident time to clean loose dirt and loam and seed in spring.

Motion carries. Five in favor.
