Call to Order

At 6:30 pm, Chair Rickert called the Regular Session meeting to order and performed the roll call.

Motion: B. Rickert moved to enter into Executive Session at 6:31 pm.

A. Executive Session: Discussion on behavior and policy

At 6:41 pm, members returned to the Regular Session.

B. Invitation to Speak:

1. Chris Burns, Community Use

C. Burns requested use of the basketball court, half or full court for 2-3 hours on any one weekday the MYC is open, excluding weekends, for travel teams to practice during the season of December 1 through the first week of March. He also requested waiver of the rental fee. He said they would consider paying for one Youth Center staff during the rental.

Members posed questions to C. Burns. A summary of the discussion follows:

- Twenty travel basketball teams need practice space (ten students per team)
- MYC members suggested many facility courts but C. Burns had investigated all spaces.
- C. Burns offered to provide the high school pool once weekly for MYC youth and waive the rental fee of \$225/hour. MYC would pay for one lifeguard per 10 kids at Community Use rate.
- Community Use coaches are CORI checked and thumb printed. The Town provides insurance.
- C. Burns acknowledged MYC would lose profit by waiving the rental fee.
- MYC provided an open calendar with rental fees to C. Burns in July 2023.

- At this late date in November, rental use is booked until 9:00 pm by prepaid renters.
- MYC rental space is not available before 6:30 pm. on most days the After School program runs
- December Gym rental space is inconsistently available throughout the month.

MYC members asked C. Burns to share revenue and cost data for planning for traveler basketball court use. He did not have the financial information available. C. Burns left the meeting so members could continue the discussion.

- Community Use makes roughly \$60,000 for the season December 1 first week of March.
- MYC does not make \$60,000 annually
- MYC secures one-third of the 10-month After School program funds through rentals.
- Milford teams already receive a discounted, resident rate to use the MYC.
- Loyal renters who support and attended MYC as youths will return in January/February.
- The rental capacity for January and February is anticipated to be too heavy.

Members discussed short and long-term scenarios:

- MYC has no need to use the high school pool.
- The Town holds the MYC Board responsible for revenue.
- MYC Board has been deliberate about rental pricing for residents versus non-residents.
- Waiving the rental fee:
 - o Don't set a precedent to favor one group over another especially non-profit rentals.
 - o Find a balance and be respectful to renters who support the MYC.
 - Community Use has more players than their space allows so they can make a profit.
- The majority of renters use the full court.
- TDA funding has not been received since the pandemic.
- YouthWorks funding, which is not guaranteed this year, supplemented the loss of TDA.
 - The MYC doesn't have a budget; we have to write and apply for grants.
 - MYC has to pay bills associated with fundraising efforts.

Action Item: Chair Rickert will ask C. Burns for a complete breakdown of revenue and costs.

Pending a Community Use revenue report, members discussed how to support the travelers:

- Convey available 2023 rental dates to C. Burns at the Milford resident rate.
- The rental fee will be 3 hours at \$245 which includes MYC staffing.
- MYC is happy to schedule traveler basketball practice in 2024 at the Milford resident rate.
- Ask C. Burns of Community Use to request rental space in late winter/early spring of 2024.
